Registration Fees:

First year and continuing FFC:

- \$100.00 per child, per year 1st-5th grade

Second year:

\$100.00 per child, plus sacramental preparation, which you pay after the Sacramental prep parent meeting.

Sacramental Preparation: (You pay this after the parent information meeting)

- \$30.00 for sacrament prep per child 2nd year only
- \$ 50.00 Unbaptized children per child 2nd year only
